Pay Rate: \$40.95 to \$42.76 per hour

The successful candidate will provide overall leadership in the planning, development and operation of treatment groups for individuals identified by CMHA with concurrent disorders. All activities are undertaken through a community development approach.

ESSENTIAL MINIMUM QUALIFICATIONS:

Education:

- ❑ Completion of a Master's degree in Social Work, Science in Nursing, Education in Counselling, Psychotherapy, Occupational Therapy, or equivalent degree.

Regulated Health Profession:

- ❑ The right to practice the controlled act of Psychotherapy within the Province of Ontario (i.e. currently a Registered Psychotherapist in the Province of Ontario and, or, qualified as a member in good standing to practice psychotherapy with a regulated health college as per the Psychotherapy Act 2007, and its Regulations, as set out in the regulations and policies of that College.) is a required qualification for this position.

Job Description

Job Title: Community Mental Health and Addictions Worker

Summary

The Community Mental Health and Addictions Worker is responsible for providing overall leadership in the planning, development, and operation of treatment groups for individuals with concurrent disorders as identified by CMHA. The worker will work with clients of CMHA who have a concurrent disorder, staff of CMHA's Community Support Services, CMHA staff working within the Concurrent Disorders Project, volunteers, external agencies and institutions, government representatives and community groups.

As part of a dynamic community program, the Community Mental Health and Addictions Worker is expected to be able to respond to situations and "new learning's" and adjust the work plan accordingly.

Reporting Relationship

The Community Mental Health and Addiction Worker reports to the Program manager assigned to supervise the Concurrent Disorders Project.

Major Responsibilities:

- ❑ In consultation with staff of the Concurrent Disorders Project and appropriate community partners, develops and implements the curriculum for treatment groups for individuals with concurrent disorders.
- ❑ Develops and maintains partnerships with identified addiction agencies to enable co-facilitation of treatment groups.
- ❑ Works with staff of CMHA's Community Support Services to assist with the identification and assessment of clients to be served by the treatment groups.
- ❑ Works directly with potential clients to assist and support their ongoing participation in treatment groups.
- ❑ Provides consultation, feedback, support and direction to the CMHA staff working with the clients participating in the treatment groups.
- ❑ Participates, as assigned, as a CMHA representative on committees, working groups, task forces in the community related to the treatment of Concurrent Disorders.
- ❑ Researches particular issues and priorities related to the treatment of Concurrent Disorders and shares information with appropriate individuals and groups.
- ❑ As assigned, organizes meetings, records minutes, writes briefs, chairs meetings.
- ❑ Participates in program and service evaluations.

All CMHA employees have fundamental responsibilities related to the organization which include:

- ❑ Maintaining up-to-date professional skills and knowledge through formal and informal training.
- ❑ Acting as an “ambassador” for CMHA within and outside the organization by creating awareness and knowledge of programs and services.
- ❑ Compliance with mandated legal/regulatory requirements related to working at CMHA e.g. Occupational Health and Safety, Employment Standards, standards of professional conduct.
- ❑ Maintaining awareness of and compliance with CMHA policies and procedures
- ❑ Attending staff and team meetings as required, participating in regular staff supervision, client reviews related to treatment groups, team meetings, information and referral assignments, planning activities and/or other activities or special assignments as directed by the Program Manager/ Executive Director.
